### Assembly on System change not climate change: uniting struggles for climate justice, rejecting false solutions, and changing the system

The Paris deal looks set to lock the world into inevitable climate chaos, with false solutions like carbon market regimes, REDD+, carbon pricing, climate smart agriculture, Carbon Capture and Storage, bioenergy, synthetic biology, geoengineering, and fracking arrogantly claiming to be able to cheat Mother Earth. In the face of all of this, communities are fighting for their lives to keep fossil fuels in the ground and are rejecting these false solutions. In the process, they are building genuine and just alternatives and solutions to the political and economic systems that are the root causes of the climate crisis. This event will look at the struggles for climate justice taking place today, and why false solutions, including a bad deal in Paris, must be rejected. Finally, it will explore the real, systemic solutions being built by social movements. System Change is not something that will happen in the future - it is something that we are building here and now.

### Burning Issues: bioenergy and other false solutions to climate chaos

Across the globe, forests are falling to fuel so-called "green power stations". Turning biomass into electricity is big business because of the huge public subsidies being paid to dirty energy companies. Biomass and other forms of bioenergy are considered renewable, but in reality they can be just as polluting as their fossil fuel equivalents - they are a false solution to climate change. As a result of the bioenergy boom, forests and the people who depend on them are suffering, with industrial tree plantations replacing diverse habitats, and dangerous new technologies such as GE trees are being commercialised.

### Does free trade leave space to act for climate?

We want to discuss the possibility of conducting ambitious policies to fight against climate change in a context of continuing liberalization of trade and investment, which places very strong constraints on the actions of national governments, regional or local in the field of energy and climate. In this case many legal provisions within the commercial field are key to define and conduct credible mitigation strategies: supporting local industries in the renewable sector, foreign investment protection deal with binding sectoral objectives (housing, transport, for example ), technology transfer, procurement ... But state and local governments must retain their policy space to define appropriate strategies and implement: the current model of the liberalization agreements allow it? Instead what were the consequences for the climate? This is what we will discuss in this context, building on experiences of the European, American and Asian.

### Zero deforestation by 2020 as one of key solutions to climate crisis

We don't want a world without forests, nor one where plantations have replaced forests. Stopping deforestation is a crucial element in the struggle against climate change. The historical UN target of aiming for zero deforestation by 2020 needs to be implemented without market mechanisms and fake forests such as plantations. But the INDCs (intended nationally determined contributions) of several countries violate this zero deforestation goal. Representatives of social movements and activists struggling to halt deforestation will present their struggles and explain how their countries' INDCs will further exacerbate deforestation instead of working to halt it. They will also present proposals for actions and supporting community conservation of forests, also other proposals from local, national, international to stop deforestation and plantations and to hold governments to account to the zero deforestation target.
