# Collective Actions/commitments

- Raise awareness and educate about FPIC and other rights of Indigenous Peoples and local communities, including amongst IPLCs themselves
- Share information on positive examples, including in local languages
- Strengthen local community capacity in transformational leadership and advocacy
- Be more radical in our interventions and proposals, while maintaining a framework of respect
- Prioritize the views and proposals of communities in our advocacy work
- Analyse which other conventions and processes might influence national government policies related to community conservation, including the UNFCCC, and strengthen advocacy activities related to those processes
- Influence the elaboration of the post 2020 Strategic Plan and possible new CBD targets, emphasizing the rights of Indigenous Peoples and local communities
- Reject and resist corporate capture of the CBD, and produce a report about the corporate capture of the CBD, highlighting the role of specific corporations that violate the objectives of the CBD to de-legitimize their presence
- Prepare submissions to CBD notifications and others (SDGs, UNFCCC )
- Monitor and document government actions, including local government actions, and advocate for better policy coherence and better enforcement of CBD related policies and laws
- Insist on integration and prioritization CBD decisions in ODA

# Collective Actions/commitments

- Elaborate shadow reports on CBD and SDG implementation
- Influence the elaboration of government reports, including National Reports to the CBD, emphasizing the rights of Indigenous Peoples and local communities
- Using indicators as an entry point for advocacy
- Contribute to Global Biodiversity Outlook and Local Biodiversity Outlook
- Contribute to NBSAPs and other policies to implement the CBD at the national level Using CCRI materials to contribute into national legislations
- Advocate for the strengthening of the CBD working group on Article 8j
- Strengthen CBD decisions on issues like GE trees, and argue for a ban on non-native tree plantations and GE trees
- Prioritize phasing out of perverse subsidies, including for monoculture tree plantations and bioenergy, and redirection of incentives to community conservation efforts and forest ecosystem restoration
- Including ICCAs from the CCRI project into National Protected Areas' and OECM's System
- To elaborate co-management of natural resources approaches based on a consensus between local governments, local communities, Indigenous Peoples and CSOs
- Reduce paper consumption and promote alternative feedstocks like hemp
